Tehama County Public Works proposes to replace the Evergreen Road Bridge (08C-0008) crossing the South Fork Cottonwood Creek southwest of the town of Cottonwood in northern Tehama County, California. The proposed project includes construction of a new bridge, removal of the existing bridge, realignment of Evergreen Road to match the new bridge location, excavation along the creek to increase the capacity of the channel upstream of the new structure, replacement of the Anderson Cottonwood Irrigation District canal crossing and pipeline under the road, and widening Bowman Road at its intersection with Evergreen Road. The purpose of the project is to replace the Evergreen Road Bridge (08C-0008), which is structurally deficient to withstand a seismic event and functionally obsolete due to inadequate curves near the bridge.
